3. **How to Apply**. Application form should be filled either in English or Hindi as per the prescribed format given at **Annexure-I**. The application with duly affixed self attested colour photograph should be accompanied by Xerox copies of the documents listed below, duly self attested with name and date. No original certificates are to be forwarded alongwith the application form: -

(a) Valid Photo ID proof.

(b) Matriculation or equivalent mark sheet and certificate.

(c) 12<sup>th</sup>/UG/PG/Diploma mark sheet and certificate as per the essential eligibility.

## 5. Mode of Selection

(a) **Scrutiny of Applications**. All applications received from the candidates will be scrutinised subject to the eligibility criteria and necessary documents and the admit cards will be issued to the shortlisted candidates for document verification & appearing in the written examination.

(b) **Document Verification**. All the shortlisted candidates will undergo document verification prior appearing in the written examination. Candidates will be required to bring their original documents and self-attested Xerox copies (02 sets) of the same as per the directives / instructions given in their admit cards.

(c) **Written Examination**. All the shortlisted candidates will undergo written examination on the basis of educational qualifications prescribed for the post. The written examination will be pen-paper based and one hour duration. The Question paper (bilingual) for written examination will consists of 80 objective type questions with one mark for each correct answer and there will be no negative marking.

(d) **Syllabus.** The syllabus will be as per their standard of educational qualification and relevant trade covering following subjects:

- (i) General Knowledge
- (ii) Mathematics
- (iii) General English

(iv) Questions on relevant trade except for Multi Tasking Staff Cadre. Mental Ability Test for Multi Tasking Staff Cadre.

(e) **Maximum Marks for written exams / trade test if any.** The qualifying marks in written exam is 50% and the candidates who qualify the written test are to be shortlisted for the trade test (where applicable). In case of SC and ST candidates, the qualifying marks shall be 45%. No relaxation in qualifying marks is admissible to OBC and EWS candidates.

(f) Merit list will be prepared strictly based on merit position as per marks obtained in written examination and will be published on the Indian Coast Guard website alongwith necessary instructions.

# 6. Important instructions to candidates:-

(a) Before applying for the post, the candidate should ensure that he/she fulfils the eligibility and other norms mentioned in the advertisement. Furnishing of wrong / false information will lead to disqualification and ICG will not be responsible for any consequence of furnishing of such wrong / false information.

(b) Candidature of the candidate is liable to be rejected at any stage of recruitment process or after recruitment or joining, if any, information provided by the candidate is found false or is not found in conformity with eligibility criteria mentioned in the advertisement.
